## PRESIDENT'S REPORT

Despite 2022 being a challenging year, the AHPA Board of Directors was still able to engage in a variety of activities and initiatives on behalf of the membership. This annual report celebrates those achievements, identifies ongoing challenges, and suggests a few possible directions for moving forward. However, as this is the final year of our strategic plan, the creation of our next strategic plan in early 2023 will provide an opportunity to dig more deeply into these challenges and brainstorm potential solutions.

Given the fact that five board positions were vacant for the whole year, this past year's successes were to some degree attributable to others who stepped in to fill the breach. This included the AHPA members who graciously participated in one or more committees. These individuals are acknowledged elsewhere in the report. As well, the three Presidential Officers each took on tasks and activities that would normally be carried out by one of the Board Chairs. These individuals, and their roles, were as follows:

Samantha Holmgren, President Elect, was responsible for the Sustainability Portfolio. This included all internal operations and policies of AHPA (e.g., conflict of interest, procedures, bylaws, organizational structure, and privacy). The President Elect also oversaw the Treasurer, Secretary, and Membership Committee.

Paul Adam, President, exercised general and active supervision over the affairs of AHPA, as well as being responsible for the Knowledge Translation Portfolio. This portfolio comprised educational and research activities including overseeing the Professional and Career Development Committee and the Research Committee. The President was also responsible for liaising with the Canadian Rheumatology Association regarding the ASM.

## PRESIDENT'S REPORT

Anne MacLeod, Past President, was responsible for coordinating the annual nomination and election of Board Members, as well as the Engagement Portfolio. This included liaising and communicating with all external stakeholders such as professional advocacy organizations (e.g., Canadian Rheumatology Association) and patient organizations (e.g., Arthritis Consumers Experts). As well, the Engagement Portfolio Presidential Officer oversaw the Website/ Communication Committee, Sponsorship and Marketing Committee, Member-at-Large, as well as the ORA/AHPA Liaison and any other active Liaison Roles.

As noted above, sharing responsibilities among the three Presidential Officers resulted in a more equitable division of tasks and activities, as has a continuing reliance on members who volunteer on our committees. We've recently had many members express an interest in taking on micro-volunteer roles, i.e., becoming involved in small, time-limited tasks. We will also be exploring the possibility of obtaining corporate sponsorship funding in the year ahead, which if successful, would allow us to transfer some tasks to a part-time paid administrative support person.

One of the major projects this year was the unveiling of the new website. The new site includes a discussion forum that we had hoped to launch this year, but which was put on hold as we addressed other unexpected events. The discussion forum has the potential to be a private or open meeting place for members wanting to exchange information, collaborate on projects, etc. The new website also has an enhanced members directory. Clinicians will have the opportunity to be part of a searchable public directory that allows patients to find care providers with the expertise to treat their type of arthritis. There is also a 'Members Only' part of the directory that will allow members to network with each other more easily.

As well, in maintaining contact with our professional and patient partners, she advocated for the interests of our members with the CRA and developed new patient partner relationships. She also took a major role in overseeing the website launch and in working with the website committee to re-imagine the Resources section of the website.

## **Strategic Pillars: Progress and Priorities**

## **Knowledge Translation**

#### **Progress in 2021-2022**

- Successful virtual Pre-Course held in February 2022 with 74 participants attending at least one of the two half-day sessions
- 4-part OnlineED webinar series focused on the overall topic of Women's Health. Individual sessions addressed sexual and reproductive health, medications and pregnancy, and fracture prevention
- Recognizing the stressors faced by our members this year and last, AHPA sponsored a 6-hour evidence-based workshop entitled Caring for Others Without Losing Yourself: Mindful Self-Compassion (MSC) Training



- Third virtual pre-course in February 2023
- Learning needs assessment in early 2023
- While continuing to hold the OnlineED webinar series there needs to be a plan to address the significant decrease in member attendance



## Engagement

#### **Progress in 2021-2022**

- Engaging our members
  - Spring 2022: Virtual launch of new AHPA website to gather feedback from members and answer questions
  - Fall 2022: Invitations sent to every member of AHPA to engage in a 15minute conversation with the Past President about ways AHPA can better meet members needs as well as to discuss opportunities for member involvement in AHPA. Over half of our members engaged in conversation (43 chats and 27 email replies)
- AHPA collaborates with other Professional and Patient Organizations to advocate for and to provide optimal care and quality of life for every Canadian living with arthritis
  - <u>Professional Organizations</u> includes the Canadian Rheumatology Association (CRA), Ontario Rheumatology Association (ORA), The Association of Rheumatology Professionals (ARP), and the Advanced Clinician Practitioner in Arthritis Care Program (ACPAC). A new partnership was established this year with the Spondyloarthritis Research and Treatment Network (SPARTAN)
  - <u>Patient Organizations</u> includes the Arthritis Consumer Experts (ACE), Arthritis Society, Canadian Arthritis Patients Alliance (CAPA), Canadian Spondylitis Association (CSA), and Cassie & Friends. New partnerships were established with the Canadian Psoriasis Network (CPN), Lupus Ontario, Sjogren's Society of Canada (SjSC), and Take a Pain Check (TAPC)
  - Initial discussions were held with <u>Research Organizations</u> to better support the work and mentoring of research trainees through AHPA activities and collaboration between organizations

- Engage our members in time limited and task-oriented activities to support the ongoing work of AHPA
- Provide opportunities for networking and connection amongst members including use of discussion forum on website, zoom platform, and possibly in person events
- Continue to engage and collaborate with Professional, Partner and Research Organizations



## Sustainability

#### Progress in 2021/2022

- In conjunction with the Membership Committee, trialed a mid-year membership drive
- Created separate adverts for clinicians and researchers that were then disseminated to nonmembers associated with a variety of formal and informal networks, e.g., pediatric rheumatology clinicians, Ontario's Arthritis Rehabilitation and Education Program (AREP), etc.



• Wrote promotional emails for the fall membership drive

- Facilitate an enhanced membership drive process for 2023 and onwards
- Collaborate with other members of the Board to create the 2023–2028 Strategic Plan
- Review the organizational structure and collaborate with other Board members to ensure the sustainability of AHPA
- Develop a system to help manage the workload and create transparency among Board members regarding project management

#### Mandate

• The Advanced Clinician Practitioner in Arthritis Care (ACPAC) Special Interest Group (SIG) has been under the umbrella of AHPA since May 2019 and is composed of graduates and students of the ACPAC program. The pillars supporting all our activities are Advocacy, Research, and Education, all underpinned by Leadership. Objectives of the SIG include fostering collaboration between graduates and trainees, supporting program graduates & trainees, providing strategic direction to those interested in extended-role practice careers, maintaining a collaborative relationship with the ACPAC program, and supporting research and professional development activities

#### Achievements

- Forty-nine members were registered with the SIG in 2022
- Subcommittees: Advisory, Advocacy, Research, and Education
- Research Subcommittee formalized and prepared to complete a scoping review examining the impact of ACPAC therapists on the health care system, specifically in the advanced practice pillars of clinical practice, education, research, leadership/advocacy, as well as investigating related literature addressing equity, diversity and inclusion principles. This was led by Laura Passalent, Julie Herrington, Lisa Caldana and Kristi Whitney
- In partnership with the Ontario Rheumatology Association, Chandra Farrer worked with Dr. Sahil Koppikar to support clinicians working in Northern Ontario. This initiative involved advocating for an interprofessional model of care utilizing ACPAC graduates to promote sustainable rheumatology care in Northern Ontario. Meetings were held with Ministry of Health representatives to advocate for sustained funding of local ACPAC graduates to work in collaboration with rheumatologists to ensure equitable access to care







#### Achievements

- Laura Passalent, along with members of the University Health Network, Division of Rheumatology, and the Rapid Access Clinic, Low Back Pain Program worked in collaboration with UCB Inc (Global) to pilot a provincial approach to screen for axial Spondyloarthritis using an interprofessional model that incorporated ACPAC trained providers
- The ad hoc medical directives subcommittee created and recorded an educational webinar on medical directives for inclusion in the ACPAC trainee curriculum
- Communication to the broader membership was achieved through regular newsletters, called "ACtion PACked News"
- ACPAC SIG members who were 2022 AHPA Award winners:
  - Extraordinary Service Award Chandra Farrer
  - Lifetime Achievement Award Sue MacQueen
  - Clinical Innovation Award Julie Herrington
- The Annual ACPAC SIG Education Event and General Meeting was held virtually on June 3, 2022. This included:
  - Model of care presentations from 3 ACPAC graduates working in diverse settings, including Jocelyne Murdoch (Northern Ontario), Mandy McGlynn (Toronto), and Leah Samson (Saskatchewan)
  - Guest speakers: Dr. Andrea Chan, who presented the Musculoskeletal Lecture on the Evidence-Based Surgical approaches to Hand Arthritis; Dr. Deborah Levy, who presented the Dr. Rachel Shupak Legacy Lecture on the Update on Juvenile Idiopathic Arthritis-Related Uveitis and Andre Picard, the award-winning Health Columnist from the Globe and Mail, as our keynote speaker who discussed Innovation in Healthcare Delivery
  - Celebration of Dr. Katie Lundon's (ACPAC co-founder) retirement from ACPAC

#### **Priorities for 2023**

- A webinar for the general AHPA membership to be delivered in early 2023
- The ACPAC SIG Advisory committee will work with members of the SIG and the ACPAC program, along with the involvement of physician and patient partners, to establish strategic goals and directions for the ACPAC network including advocacy, research, and educational activities
- Delivery of 2023 Annual ACPAC SIG Education Event and General Meeting including model of care and guest presentations
- Ongoing Advocacy work to secure funding for an ACPAC position in Northern ON.
- Research committee anticipates being able to share preliminary data at the next AGM in June 2023

## FINANCIAL OVERVIEW


